Employment Pathways is committed to helping anyone, who wants to work, achieve their goals through person centered planning and employment support. Staff provide assistance to job seekers with disabilities in Warren, Morris, Sussex, Hunterdon, and Somerset counties. Job titles included service roles, retail sales, junior business coordinator, clean team, bakery associate, kennel assistant, operating room assistant, and dietary aide. Notably, one individual was offered a salaried position at \$40,000 per year with full benefits at a technology firm.
